"The Rote Hilfe (Red Aid) is a leftist organization engaged in providing protection and support. It is independent of any party and transcends the various streams of the political left. To the best of its abilities, the Red Aid supports solidarity for all those, irrespective of party membership or weltanschauung, who are subject of repression in Germany because of their political activities.

Political activities in this sense include activities on behalf of the goals of the worker's movement or of international solidarity, the fight against fascism, sexism, and racism, the fight for democracy, unionist struggles, as well as the fights against antisemitism, militarism and war. Our support goes to all those who lose their jobs, who are subject to occupational bans, who are dragged before the courts or sentenced to fines or imprisonment or who suffer other disadvantages. Moreover, the Red Aid proclaims its solidarity with all those persecuted by the forces of reaction in all countries of the Earth"

Sect. 2 of the Red Aid Charter

As of the fall of 2018, more than 9,500 people all over Germany are members of the Red Aid, with active political work being done in more than fifty local and regional groups. Over the last few years, the Red Aid has turned into one of the largest member organizations of the left. Its members come from all parts of the German left, including members of

- * the communist, socialist and anarchist movements.
- * the peace and antimilitarist movements,
- ★ the movement against nuclear power and nuclear armaments and the movement against the "Castor" transports of nuclear waste,
- ★ internationalist and anti-imperialist groups,
- * the ecological movement,
- ★ legal aid groups and those fighting for civic and human rights and liberties,
- * the antifascist movement.
- ★ the feminist movement and women's/lesbian groups,
- ★ antiracist groups and the refugee movement,
- * trade unions.
- ★ groups engaged in workers' struggle and diverse other social struggles.

Accordingly, the Red Aid has lived up to its character as an organization transcending the various streams of the political left and has shown that it is possible to conduct common political activities on that basis.

Solidarity is Our Weapon

The Red Aid as an organization forming part of a country-wide network is able to compare and analyze acts of repression (e.g. in the "Rote Hilfe Zeitung", the quarterly magazine published by the organization) and to bring together those combatting repression (e.g. in country-wide campaigns). The Red Aid does not aim to "replace" local antirepression groups (such as Ermittlungsausschüsse or "Fact Finding Committees", Bunte Hilfen or "colorful aid groups", mutual support funds, committees for the incarcerated etc.), but to complement their work with our common activities. In most cases, those facing repression for their political activities will receive support from the political circles responsible for these activities. We feel that this self-evident form of solidarity is the most important of all. However, there will always be people who, e.g., participate in a demonstration on their own and who do not have ready access to support networks in case of, e.g., an arrest. And sometimes the strain of monetary costs or of public outreach activities simply cannot be borne by one group alone. It is in these cases that a nationwide organization with many members can provide aid and support. Similarly, many political cases are drawn out over many years, some only arise years after the groups conducting the political activities have ceased to exist in their original form.

The continuing political activities of the Red Aid aim to prevent repression from becoming an individual problem and to protect individuals and groups against feeling left alone with the costs of trials or with periods of imprisonment.

Support for the individual is always meant also to strengthen the movement as a whole. We wish to ensure that everyone participating in political struggles does so knowing that they will not be left alone if their activities lead to prosecution. The state and the forces of reaction are trying to combat left wing politics as a whole by targeting individuals, by way of exemplary punishment, a strategy based on isolating certain people or groups from the rest of the left and from society more generally. In fighting against this strategy of isolation and division, the Red Aid bases itself on the principle of solidarity. We wish to work together in combating the ruling class policy of division and intimidation – leaving aside for the moment all differences within the left concerning political theory and practice. We thus wish to encourage all members of the left to continue fighting for their political goals.

What Does the Red Aid Do?

Probably the most important task of the Red Aid is to provide financial support in cases of indictments and court cases. Our goal is for the financial pressure of court costs, fees and lawyer's costs to be borne collectively. Accordingly, upon a motion by the person suffering repression, the Red Aid carries a share of currently 50% of all costs incurred – in cases of dire need, a follow-up motion for additional monetary support can be made. In the year 2017, the Red Aid was able to pay out more than 380,000 Euros in monetary support in this manner. One of the basic principles of the Red Aid is that it also supports non-members when they are subject to repression based on their political activities. Besides the general funds for monetary support, there are frequently calls for donations covering specific causes.

However, the Red Aid does not see itself as a "Red Charity Organization" or a leftwing legal expenses insuran-



ce. Accordingly, it provides not only monetary, but also political support. Such support can take the form of calling for donations, organizing solidarity events, sending observers and supporters to court dates, and taking care of the needs of political prisoners. In addition, the Red Aid has set itself the task of combatting political repression in a more general sense. Accordingly, ever since the founding of the Red Aid, we have tried to educate people about various forms of political repression and about the institutions engaged in that repression (police, state security police, secret service agencies, the military and the judiciary) not only in the context of demonstrations. but also much earlier. By organizing presentations, by publishing leaflets and pamphlets, we wish to work towards a state of affairs in which activists know how to protect themselves and others against injuries and arrests and what rights they (at least formally) have. The Red Aid is also engaged more generally in the fight against reforms of the law on demonstrations leading to further restrictions, against "state security laws", against a slashing of the rights of the defense, against solitary confinement and torture, against restrictions of freedom of speech and of other civic rights and liberties.



Organize the Red Aid!

The Red Aid calls upon everybody to refuse to accept political oppression and persecution – in Germany or elsewhere - and instead to organize and work together in combatting them! Only an organization which is independent of political parties, which is active continuously and which organizes many members is able to ensure that all those suffering from political repression are given as much of the help they need as possible. This must necessarily be a country-wide organization which is therefore able to continuously do its work independent of day-to-day politics and to reliably provide financial support based on regular donations and members' dues. A country-wide solidarity organization like the Red Aid is necessary so that someone feels responsible for everyone facing political repression – even if they come from the remotest village, no matter what part of left-wing movements they belong to. The Red Aid is necessary to be able to react on a national level against law reforms furthering repression, against waves of arrests and indictments, and to initiate and support campaigns on a national level financially and politically.
